FOR THEIR \$45/\$50 DONATION, EACH PERSON RECEIVED A LOVE RIDE PIN, AN OPPORTUNITY TICKET AND A PROGRAM. PRE-REGISTRANTS ALSO RECEIVED A LOVE RIDE 29 PATCH. EVERYONE ATTENDING IS ENCOURAGED TO MAKE ADDITIONAL DONATIONS EITHER PERSONALLY OR BY COLLECTIONS FROM FAMILY, FRIENDS, COLLEAGUES, ETC. AND ARE GIVEN VARIOUS INCENTIVES FOR THE DONATIONS. THIS YEAR INCENTIVES INCLUDED OPPORTUNITY TICKETS FOR VARIOUS PRIZES. FOR EACH \$10 DONATION, THE PARTICIPANT RECEIVED AN OPPORTUNITY TICKET TO WIN A HARLEY DAVIDSON MOTORBIKE, A TRIP FOR 2 TO MILWAUKEE, WI (INCLUDING HOTEL) TO VISIT THE HARLEY DAVIDSON MUSEUM, AND VARIOUS OTHER PRIZES. OTHER PRIZES WERE AWARDED TO THE TOP FUNDRAISERS. PLANNING AND LOGISTICS FOR THE LOVE RIDE BEGINS IN LATE JUNE, WITH GENERAL PLANNING AS WELL AS SPECIAL COMMITTEE MEETINGS. AT LEAST 9,000 VOLUNTEER HOURS ARE SPENT BY APPROXIMATELY 35 VOLUNTEERS WHO WORK ON THE PLANNING AND LOGISTICS TO ASSURE A SMOOTH EVENT.
