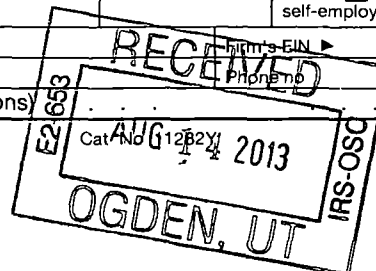

- (1) **Vaccination and Child Survival** - The Project objective is to examine the impact of vaccinations on child survival at INDEPTH Centres in Africa. It will try to establish whether gender has any relationship to survival and specific vaccinations.
- (2) **MSc Leadership Programme** - This is an INDEPTH initiated MSc programme in Field epidemiology which is hosted at the University of Witwatersrand in South Africa. The main aim of the programme is to help train young scientists at INDEPTH Centres in population based field epidemiology to help build human resource capacity at the Centres and also to provide training in leadership.
- (3) **Wellcome Trust Strategic Award** - The aim is to help improve the quality of data generated and to share this information with other public health scientists and policy makers. The first set of data is now available on the web.
- (4) **Sexual Reproductive Health** - This project is looking at issues relating to reproductive health and the rights of vulnerable population in developing countries.
- (5) **CLIMIMO Project**: The aim of this study is to look at the effects of climate change on mortality patterns among the participating centres. Once a pattern is established, it would help to design interventions for the rest of the members in the network.
- (6) **Cause Specific Mortality Project**. This project plans to use data accumulated over a period of time at these centres, and try to determine the specific causes of death across all ages and gender. This will help to determine the burden of such diseases and contribute to better planning by public health professionals and policy makers.
- (7) **INDEPTH UNIVERSAL HEALTH COVERAGE** - This project seeks to use the unique position of INDEPTH Platform in Africa and Asia to understand the impact of various health sector reforms on the population particularly the poor and vulnerable in society.
- (8) **INDEPTHStats**:- This is INDEPTH Data that is freely available to everyone. Its aim is to provide Researchers, Government officials, policy makers, among others, health and demographic information that can guide their decision making. These include crude birth rates and death rates, age-specific fertility rates, infant, child and under five mortality rates as well as other health and demographic indicators.
- (9) **INDEPTH ANNUAL GENERAL MEETINGS**: This is an annual general assembly of the member Centres to take stock of the activities of the network and to help develop, direct and drive the scientific agenda of the Network.
- (10) **AWI-GEN Project**. This is a study funded by NIH to conduct research on genetic factors for cardiometabolic diseases in Africans.
- (11) **INTREC** - This is an EU funded project which focuses on developing capacity at INDEPTH Centres to conduct research on social determinants of health.
