It takes a value chain approach, starting with training new scientists and ending with putting improved seeds on the shelves of village-level agro-dealers.

The program has four key components:

- 1- The Education for Africa Crops Improvement (EACI)
- 2 - The Fund for the Improvement and Adoption of African Crops (FIAAC)
- 3 - The Seed Production for Africa (SEPA)
- 4 - The Agro-Dealers Development Program (ADP)

- Supporting efforts to expand regional trade
