Peru Volunteer Program. In 2012, 122 young people participate in our volunteer program, which is oriented towards fostering understanding of Peruvian culture as well as professional development in the areas of medicine, music, education and engineering. We executed 10 medical campaigns serving 1133 patients and invested more than 12,640 volunteer hours and \$10,900 in material donations and community outreach to promote development in Peru. Volunteers also participated in health prevention and education workshops which they put on for the community as well as 3 Christmas events where over 600 toys were distributed to children in the community. An Internet tower was installed in Campina La Merced - Laredo as part of this project as well.
