The Local 390 monthly minutes and E-Board minutes are also available upon request.

This Locals sole source of income is from membership dues. This Local is the administrator of a dental plan (Delta Dental). Premiums are collected from the dental plan participants and the Local then pays the monthly premiums to Delta Dental of Minnesota.

At the end of the reporting period, there were 630 active members that pay \$12 per pay period for dues and 23 retired members that pay \$20 per year for dues, equaling 653 members that made up the governing body at the end of the reporting period.

At the end of the previous reporting period for total assets was \$166,941, which the report was completed under Trusteeship. The current Treasurer (this signer) computed total assets at the beginning of this reporting period at \$172,040. This Local was under Trusteeship during previous reporting period and part of this current reporting period. Prior to that, bookkeeping was an issue. This Local has now obtained a lap top computer and purchased the Quick Books program as a step to improve the bookkeeping of this Local.

This report is extremely late due to the difficulty with archiving and retrieving all information necessary for an accurate report. This signer accepted the Treasurer position in June 2012, though didn't attend Financial Officers training until May 2013 and LM report training until September 2013. As Local 390 Treasurer, I am requesting a waiver of any penalties due by the Local for the late filing of this report.
