IAMU PROVIDES JOB TRAINING AND SAFETY SERVICES TO 11 "SAFETY CLUSTERS" - REGIONAL ORGANIZATIONS OF LOCAL GOVERNMENTS THAT OPERATE 260 SEPARATE UTILITIES.
