Rally Foundation Research Grants Program:

Rally Foundation supports all phases of childhood cancer research from science at the bench (very early research) to Phase I, II, and III clinical trials including targeted therapies, DNA studies and survivorship studies. Rally Foundation is also excited to help fund the collaborative research of more than 5,000 physicians, scientists and nurses at 200 hospitals nationwide. These physicians and nurses treat more than 90% of the children in the US with cancer. Eighty percent of these children are enrolled in clinical trials. Rally gives research grants once a year, during the fourth quarter of its fiscal year - January through March. In fiscal year 2012-2013, Rally Foundation gave away more than \$1 million funding 45 such grants, bringing it's total grants to over \$4,000,000 supporting 116 research projects over the past 7 years.

Rally Foundation Public Education and Awareness:

Rally Foundation has educated more than 400,000 people on the need for childhood cancer research and has engaged approximately 3,750 volunteers. In 2012, Rally had over 20 million media impressions. Most of Rally's Public Education and Awareness Programs are grassroots efforts to inform the public about the need for childhood cancer research.
