CARING is licensed by the NJ Department of Health and Senior Services to provide Assisted Living Program (ALP) services -nursing care, homemaker services, personal care, assistance with medication, doctor appointments and transportation to residents of publicly subsidized units in their own apartments. Currently, CARING provides ALP services to eligible residents of the Atlantic City Housing Authority Jeffries Tower, Inlet Tower and John P Whittington Center, the Wildwood Housing Authority Sandman Towers, Millville Housing Authority Riverview West and Jaycee Plaza and Camden's Northgate II. CARING provides those residents with the services they require to "age in place" rather than move into a long-term care facility.
