general brochure, as well as acting as a resource for the media.

Provided free legal information and advice to callers from throughout the United
States concerning issues such as family leave, and sexual harassment and
discrimination in the workplace and in schools through the Organization's toll free
Advice and Counseling line. In addition, the Organization provided callers with
referrals to attorneys and other advocacy organizations. The Organization's
services were provided in multiple languages through the use of bilingual staff and
a telephone translation service.

Worked closely with community-based organizations and other civil and human rights
organizations to promote social justice and equal rights and opportunities for women
and girls, including promoting public policies more responsive to the Organization's
constituents; supporting and opposing legislative measures based on their
anticipated effects on the Organization's constituents; and expressing the
Organization's views with regard to judicial nominees
