The Society for Mathematical Biology's mission is to promote scientific collaboration between the Mathematical and Biological communities.

The Society publishes a highly regarded scientific journal, "The Bulletin of Mathematical Biology". There are 12 issues each year, available both online (SpringerLink) and in paper back. The Society pays the publisher, Springer, a certain amount per member for online access to the Bulletin and a bit more for those members who want the paper back copies as well. Springer in turn pays the Society a royalty payment based on the income the Bulletin generates. These royalty payments provide the Society with funds the Society uses to provide travel support for students participating in the annual Society conference and travel support for students participating in other Mathematical Biology related meetings. The Society is also able to use some of the funds to provide travel support to its officers, board members, committee chairs, and plenary speakers to attend the annual meeting.

In addition to the Bulletin, the Society publishes three newsletters per year, distributed in paper format to Society members and also available (to anyone) on the SMB website. The Society also publishes an electronic newsletter, "The Digest". It is free and it is sent via email to over 2000 subscribers, at least twice a month.

4b (Code) (Expenses \$ 43,183 including grants of \$ 17,183) (Revenue \$ 521)

The Society held its annual meeting at the University of Tennessee in Knoxville, attended by 400 plus participants (about 260 Society members and about 150 non members). The annual meeting provides an opportunity for Mathematical and Biological scientists to come together and interact in a congenial atmosphere. The basic expenses of the meeting were covered by the registration fees and were handled inhouse. The Society covered expenses associated with student travel awards and two presentation awards, along with travel support for Society officers, board members, and committee chairs.

The Society provided financial support to 5 Mathematical Biology oriented Conferences, both within the United States and outside of the United States. The Society has a World Outreach Program which is designed with the goal to promote and help establish programs in Mathematical Biology, especially in developing countries
