Note (14) Prior Period Restatement

In July 2012, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update No. 2012-01, *Health Care Entities (Topic 954): "Continuing Care Retirement Communities – Refundable Advance Fees,"* which amended the Health Care Entities topic. This standards update affected continuing care communities that have resident contracts that provide for a payment of refundable advance fee upon re-occupancy of the unit by a subsequent resident. Three Crowns Park's 90% refundable contract requires that at least 90% of the entrance fee be refundable upon re-occupancy by a subsequent resident but is not limited to the proceeds of re-occupancy. Previously, the refundable portion was accounted for as deferred revenue amortized to income over the life of the building, which is forty years. Retroactively, the refundable portion is to be accounted for as a liability (advance fees) and is not amortized into income.

The standards update is effective for fiscal periods beginning after December 15, 2012, requiring a retrospective adjustment to opening unrestricted net assets as of the beginning of the earliest year presented. Management has elected early adoption and the effect of the restatement on the change in net assets and financial position as of April 1, 2011 and for the year ended March 31, 2012, are as follows:
