The Office of Foundation Liaison was established in 2003 to manage strategic partnerships between foundations and state government to improve the lives of Michigan citizens. Funded by foundations the offices of three staff is located in Lansing with direct access to the Governor. The Office of Urban & Metropolitan Initiatives is focused on economic impact and job growth initiatives respective to urban and metropolitan areas. This office includes a staff of five located in key areas around the state. Support for this office comes from both foundations and the business community.4c (Code) (Expenses \$ 491,809. including grants of \$) (Revenue \$)Transforming Michigan Philanthropy Through Diversity & Inclusion (TMP) is a seven-year initiative started in 2008 designed to increase the effectiveness of organized philanthropy in Michigan. Its vision is for organized philanthropy to be a catalyst for positive social change. The objectives are for CMF to become a diverse & inclusive membership association, to increase member awareness, understanding and support voluntary action to become more diverse and inclusive, and to increase the diversity of individuals serving, leading, governing and advising foundations and corporate giving programs.
