SUPPORT TO AFFILIATES Significant resources were raised and expended to support members of the BCTMG who had been locked out by their employer - American Crystal Sugar. Support included direct relief aid to the workers media messaging, coordinating national support, and direct actions such as rallies and picketing. We also worked to support the musicians of the St Paul Chamber Orchestra and the Minnesota Symphony Orchestra who had been locked out by the governing boards of those Organizations

LEGISLATIVE In the first few months of the fiscal year we continued to organize and coordinate a comprehensive lobbying effort among our affiliates to ward off a "Right to Work" constitutional amendment and other attacks on organized labor including attempts to weaken the prevailing wage law, to dismantle the Public Employee Labor Relations Act, and to eliminate seniority rights. We also coordinated lobbying efforts in support of a Capitol Bonding Bill and a proposal to build a new stadium for the Mn Vikings. Efforts included recruiting volunteers from the various unions to attend legislative hearings and demonstrations outside of the House and Senate Chambers. The last few months of the fiscal year, working with new majorities in the State House and State Senate we initiated legislation to raise the minimum wage and to reform worker's compensation. We worked to include language in the legislation creating the Mn Health Care Exchange that addressed the concerns of a number of our affiliates. We supported legislation to increase funding for nursing home employee compensation, P-12 Education, Higher Education, Local Government Aid and state services. We advocated for increased taxes to pay for those funding increases. We also supported a bonding bill to rehabilitate the State Capitol. Working with AFSCME and SEIU we worked to pass legislation allowing child care workers and home health care aids to organize into a union.

POLITICAL Labor 2012 was the largest political effort yet undertaken by the Minnesota AFL-CIO. Working with our affiliates we reached out to educate union members across the state on electoral issues and candidates. Our efforts helped to defeat two proposed constitutional amendments, change the balance of power in both the State House and State Senate, and defeat a sitting congressman with a labor friendly candidate.

The effort included extensive use of targeted mail, door to door canvassing, the use of phone banks and workplace leafleting.

At the end of the campaign, extensive work was done to ensure that union members actually voted in the election.

Thousands of volunteer hours went into this effort
