U.S. Program—Global Alliance for Incinerator Alternatives provided technical support and information to dozens of members and allies in the U.S. as they worked to address pressing waste issues in their communities. For example, we continued to support the Boston Recycling Coalition in research, project development and policy planning to increase the city's recycling rate; worked with partners Oakland, CA in an effort to increase wages and job quality for recycling workers sorting Oakland's recycling, and to improve certain recycling programs, in particular by providing messaging support; and supported communities advocating against incinerator proposals in over a dozen U.S. cities. We maintained an active members mailing list engaging more than 200 individuals and organizations in the U.S. We organized a state policy strategies meeting in Newark, New Jersey in May 2012. We partnered with the City of San Francisco to organize "Zero Waste in Action: San Francisco's experience creating a zero waste infrastructure," a three-day learning opportunity in February 2013 to give city officials and advocates from across the country (and beyond) a chance to see successful systems and infrastructure in action and discuss the economics, politics, and practical issues of implementing effective zero waste systems. We undertook mapping of recycling jobs creation strategies, looking at a diversity of approaches and policy drivers, speaking about our findings at various venues and "Remade in America" briefings that we organized with the Rockefeller Foundation. We also circulated a briefing document on our findings, along with other informational materials produced by GAIA.

numerous other countries in all regions of the world, and supported an international list reaching a substantial number of our 800+ global members. We worked to make visible the contradiction between Europe's own waste policy and the kinds of international development projects that European carbon markets are supporting, including through a briefing at the European Parliament. We published The European Union's Double Standards on Waste Management & Climate Policy (addressing this contradiction) and a collection of zero waste case studies titled On the Road to Zero Waste: Successes and Lessons from Around the World. We co-wrote and released The Green Climate Fund's "No-Objection" Procedure and Private Finance: Lessons Learned from Existing Institutions." We also organized "Toward Sustainable Cities and Communities - Zero Waste Centers of Excellence," a conference at the Rockefeller Foundation's Bellagio Center, which brought together community and worker activists and city officials on the cutting edge of solutions-oriented approaches to waste around the world. We also launched a new blog, www.zerowasteworld.org.
