Brand Execution & Market SegmentationTake Me Fishing - All of RBFF’s consumer outreach, whether electronic, print ads, event signage, TV or radio, carry the evocative, participation-building Take Me Fishing brand In FY 2013, awareness of the brand from Take Me Fishing communications increased among those with a general interest in the outdoors, logo recall more than doubled to 46% and recall of the phrase "Take Me Fishing" grew to 41% from just 12% the previous year Take Me Fishing advertising scored a solid 76.6 out of 100 in its ability to influence readers' decisions to go fishing This year, RBFF's press outreach translated into 713 million impressions Social media exposure grew dramatically, recording more than 181,000 Facebook "Likes" and Twitter followers

Boating and Fishing Stakeholder Engagement - This combined initiative focuses on developing products and programs and providing research and communications to industry stakeholder groups about RBFF activities This initiative also encompasses RBFF's presence at numerous industry stakeholder events - Education - The Education Initiative was made part of the broader Boating and Fishing Stakeholder Engagement Initiative in FY 2012 Each year, RBFF awards grants to organizations dedicated to educating and engaging children in the outdoors, particularly in boating, fishing and aquatic conservation, with a required outreach to minorities and underserved communities This year, new grants were awarded to five organizations, which together reached more than 125,000 young people - RBFF also partnered with 66 corporations and NGOs which featured our Places to Boat & Fish embeddable map on their websites

Digital Communications- TakeMeFishing.org, along with RBFF's other digital and interactive tools were separated and established under the Digital Communications Initiative in FY 2011 TakeMeFishing.org is RBFF's award-winning website for involving Americans in boating and fishing and increasing awareness of aquatic resources Unique site visitors rose to almost 6 million in FY 2013, an increase of 13 percent - Mobile TakeMeFishing.org - Site visits to the mobile, smartphone version of TakeMeFishing.org more than doubled from the previous year The Take Me Fishing Boat Ramp App is another recent smartphone innovation The app identifies and directs users to conveniently located boat ramps from its database of 35,000 boat ramps nationwide Since its launch in 2010, the free, award-winning app has been downloaded more than 93,000 times and managed over 1.5 million queries
