To Articles of Incorporation and Bylaws of
Colorado P.E.O. Charitable Corporation
(Formerly known as Colorado P.E.O. Chapter House, Inc.)**

Articles of Incorporation

Amended Article I to read:

The name of our said corporation shall be Colorado P.E.O. Charitable Corporation.

Explanation: Changed name of the corporation from Colorado P.E.O. Chapter House, Inc. to Colorado P.E.O. Charitable Corporation.

Amended Article V, section A to read:

Board of Directors. The management of the affairs of the corporation shall be vested in a Board of Directors, except as otherwise provided in the Colorado Revised Nonprofit Corporation Act (the "Act"), these Articles of Incorporation, or the bylaws of the corporation.

Explanation: Specifies that management of Colorado P.E.O. Charitable Corporation is by a Board of Directors, rather than a Board of Trustees, except if otherwise provided by stated "Act", Articles or bylaws.

Amended Article XI on Dissolution

Explanation: Would specify that in case of dissolution of this corporation, assets remaining after donor's requests shall be distributed for charitable purposes only to charitable organizations which are exempt under Section 501(c)(3) of the Internal Revenue Code, any assets not so disposed of shall be disposed of by the Court of competent jurisdiction of the county in which the principal office of the corporation is located, and that no members, director, officer of the corporation or private individual shall be entitled to share in the distribution.

Bylaws

Amended by striking out Article II and inserting new Article II and III to read:

Article II - ESTABLISHING ACT - The Colorado Foundation Fund of the P.E.O. Sisterhood was incorporated as a Colorado corporation on July 20, 1949 under Colorado Secretary of State's document number 116747 (later renumbered as 19871180800). On July 2, 1963 under Colorado Secretary of State's document number 167369, the Articles of Incorporation

were amended to (1) include among the objects and purposes of the corporation the receipt of funds for the philanthropic, benevolent, charitable, and non-profit benefit of members of the Colorado State Chapter of the P.E.O. Sisterhood, and (2) establish the corporation as a non for profit corporation. Only July 2, 1965, under Colorado Secretary of State's document number 180800, the Articles of Incorporation were amended to change the name of the corporation to Colorado P.E.O. Chapter House, Inc. On July 6, 2012, under Colorado Secretary of State's document number 20121371156, the Articles of Incorporation were amended to change the name of the corporation to Colorado P.E.O. Charitable Corporation.

Article III - OBJECT AND PURPOSE - The primary, but not sole, object and purpose of Colorado P.E.O. Charitable Corporation shall be to receive contributions, membership dues, gifts and bequests for the philanthropic, benevolent, charitable and non-profit benefit of members of the Colorado State Chapter of the P.E.O. Sisterhood, and non-members. The primary activities of Colorado P.E.O. Charitable Corporation shall include but not be limited to:

a. maintaining and operating a home (hereinafter called Colorado P.E.O. Chapter House) for the benefit of members of the P.E.O. Sisterhood, qualifying members of their families, and persons who are not members of the P.E.O. Sisterhood but who are sponsored by a P.E.O. and meet criteria established by the Colorado P.E.O. Charitable Corporation and b. Maintaining and operating the Colorado P.E.O. Marguerite Fund to provide assistance to Colorado P.E.O. members and non-members.

Amended Article VI Section 1 – NUMBER OF DIRECTORS – Colorado P.E.O. Charitable Corporation shall be administered by a Board of Directors of seven voting members. Four members shall be elected by the members of Colorado P.E.O. Charitable Corporation, one of whom, when feasible, shall be a past president of Colorado State Chapter. The president of Colorado State Chapter, the chairman of the Chapter House Trustees (as defined below) and the chairman of the Marguerite Fund Trustees (as defined below) shall serve as ex-officio members. The vice president of Colorado State Chapter shall serve as an ex-officio member having a vote in the absence of the president of Colorado State Chapter.

Explanation: Would change the corporation's administration from a board of eight trustees to a board of seven directors.

Amended Article VII – OFFICERS

Section 1. Officers. (first sentence) - Officers shall be chairman, vice chairman, secretary and treasurer.

Explanation: Added office of vice chairman to the list.

Section 4. Term of Office – A term of office shall be one year. No directors may serve in the same office more than two (2) consecutive terms. The term of office shall begin immediately following election.

Explanation: Added second sentence to restrict consecutive terms in one office.

Amended Article VIII – COMMITTEES – Committees may be appointed by the chairman with the approval of the Board of Directors. The chairman shall be an ex-officio member of all committees. In no case shall any committee have the authority to act for the Board of Directors.

Explanation: Second sentence was revised to name chairman rather than Director of Chapter House as ex-officio member of all committees.

Amended Article IX – FINANCE – Adding Section 3. Annual Audit. The treasurer shall send a copy of the annual audit of Colorado P.E.O. Charitable Corporation to the president of Colorado State Chapter.

Amended Article X – COLORADO P.E.O. CHAPTER HOUSE

Explanation: Seven sections of this Article outline the Purpose; Administration; Appointment of Trustees by President of Colorado State Chapter, P.E.O. Sisterhood; Meetings of Trustees; Officers; Finance; and Dissolution.

Amended Article XI – COLORADO P.E.O. MARGUERITE FUND

Explanation: Ten sections of this Article outline the Purpose; Administration; Appointment of Trustees by President of Colorado State Chapter, P.E.O.
