Spring Sahavas May 2012. Three day retreat with talks by guest speakers of their life experience with Avatar Meher Baba, devotional songs, prayers, media presentations, workshops, group sharings, and dramatic presentations plus children's programs including crafts and other activities. Staff was all volunteer. Expenses were incurred for food, supplies, equipment rental, site preparation and upkeep during the event, advertising and promotion, guest travel and accommodation. 97 attendees. The aim of the retreat was to enhance the spiritual life of participants.

**4b** (Code ) (Expenses \$ 6,179 including grants of \$ 0 ) (Revenue \$ 9,911 )  
Infinite Intelligence Course May 2012. Nine day study course delving into Avatar Meher Baba's cosmology and metaphysics. Presented by the editor of numerous books by and about Avatar Meher Baba who brought over 40 years of study to the course with slide presentations, talks, debates, and discussions. 27 attendees. Expenses were incurred for food, equipment rental, guest travel and accommodation, course and site supplies. The aim of the course was to provide an indepth study of Avatar Meher Baba's teachings to strength the spiritual life of the participants.

Avatar Meher Baba Perpetual Public Charitable Trust Development Grant. as part of Meherana's community service at large, we participate in a grant for development of a spiritual retreat center in Meherabad, Ahmednagar, MS India which is similar to Meherana.

Costs incurred were for printing and postage for a mailing of 571 addresses.

Regular Meetings consisting of programs of prayers, readings, devotional songs, films, & videos held weekly with an average of 10-15 people attending. Monthly service week-ends where volunteers work on the property doing service projects as part of individual retreats. Costs incurred are for insurance, property maintenance, basic supplies, utilities, & rented toilets.

New Life Retreat Oct 2012 - Devotional 2-day gathering dedicated to the life & teachings of Avatar Meher Baba. Food & basic necessities were provided for the program of devotional songs, prayers, talks by guest speakers, media & dramatic presentations as well as a children's program with crafts & other activities. Staff were all volunteers. Expenses were incurred for food, supplies, equipment rental, site preparation, travel cost and accommodation of guest speakers. 61 people attended.
