Thirty-three chapters across the state locally promote the CNPS mission. All enjoy
the strengths and legal benefits of being one incorporated non-profit organization,
but chapters select projects according to interests of local members, elect their own
officers, and manage their own finances. The Society office in Sacramento handles
common administrative work and is the center point for statewide programs. Overall,
33 chapters contribute more than 90,000 volunteer hours each year.

Continued the Plant Science Program. Conducted research in collaboration with
numerous agencies (including Bureau of Land Management, California State Parks,
Natural Resources Conservation Service, and US Forest Service) to collect vegetation
field data and map vegetation in Carrizo Plain National Monument, State Park lands,
San Joaquin Valley, and National Forests. Worked on adding field samples in the CNPS
Rapid Assessment/Releve Database. Analyzed over 1,000 field surveys to categorize
the diversity of grassland types of the Great Valley in California and to classify
the vegetation types of the National Park Lands of the Mojave Desert in California,
Arizona and Nevada.

The Education Program provides botanical learning experiences for students in all
ranges of age and experience. CNPS held five workshops with 87 participants. Workshop
instructors focus on teaching job skills for surveying rare plants, wetland plants,
and vegetation. Continued the Rare Plant Treasure Hunt which engages chapter members,
volunteers and students in citizen science by collecting data important for
conservation of rare plants. Develop educational materials including a free
downloadable nature journaling curriculum that has been distributed to over 1000
teachers and naturalists to date.


