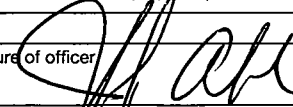
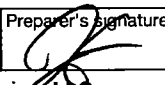

Expense 4b is a more material expense this year for the organization. Donated funds are used to setup conferences that serve as outreach for impoverished persons in Uganda.

Statement of Hands of Love Foundation Accomplishments:

Fed, clothed, educated and met the basic needs of 1,400 AIDS orphans and abandoned children living in Uganda through child sponsorship programs, and unsponsored child giving. The money wired to Uganda to care for for these kids was spent on food, clothing, basic medical, basic dental, beds, and primary school education. Built ground floor of 5-story building in Kiteezi which is being used for classrooms, staff offices and a general assembly. Once building is finished it will be able to house 800 kids and have 17 classrooms. Sent nine successful mission teams to visit orphanages in Uganda, including one medical team that delivered thousands of dollars worth of medicine and medical supplies. Supported Youth Ablaze Conference and ministered to over 1,000 Ugandan children over the course of three days. Many of these children are poverty-stricken and abandoned or orphaned.

Form 990 Part VI question 12c: conflict of Interest policy is reviewed by board members on an annual basis and books and records are inspected to ensure donated funds are used for express purposes. Regular visits are made to Uganda to oversee the use of donated funds.

Form 990 Part X explanation: applied ASC 958 in the current period which resulted in a prior year reclass of \$70,859 of retained earnings to unrestricted net assets (\$770) and temporarily restricted net assets (\$70,089). Change did not have a material impact on the foundation.

Form 990 Part XII: given the organization is growing in size and plans one day to have audited financial statements, a decision was made to move to the accrual basis of accounting. This change had no impact on the prior period or current period as there has never been a difference between either methods of accounting.
