- 1 Briefly describe the organization's mission: The ICAK's mission is the advancement of AK. It accomplishes this by uniting practitioners around the world through the founding of country or regional chapters with bylaws in agreement of those set by the International Council (IC) and its executive. A business meeting of the IC is held annually in different host countries with the executive and all chapter and committee reps present. Also, each committee exec meet, followed by an educational and science conference and preceded by proficiency exams to cert teachers.

In September, 2012, ICAK-Canada hosted our annual meeting in Montreal. The IC business meeting was held on the first day as well as proficiency and teacher certification exams. On days 2, 3 and 4, a congress was held with speakers from around the world resending papers on AK related topics. A grant of \$11,130 was paid by cheque to ICAK-Canada to cover costs incurred by the host chapter, for IC members attending whose conference fees are, covered by this grant. The remaining expenses cover per diems for IC members attending the business meeting and honorariums for the executive for attending the meeting and their work on behalf of the organization throughout the year. The IC receives no income from the meeting as the host chapter takes on all the responsibility of organizing and running the congress. The IBE (International Board of Examiners) does incur costs (room booking and per diems for examiners) and receives income (fees paid by those sitting for exams) but these are summarized in parts IX, line 19 (\$17,065 of 19,165 stated) and VIII, line 2a (\$20,922) respectively and represent annual total expenses and revenues for examinations held in Dallas TX, Montreal, Oxford UK, and Seoul S. Korea during this fiscal year. The IBE has its own treasurer and maintains its own bank and paypal accounts and submits to the IC treasurer an annual financial report which is included in the Revenue and Expense totals of this filing. See 4c below.

4b (Code:) (Expenses \$ 15,000 including grants of \$ 15,000) (Revenue \$)
For a second year in a row, in support of the same research initiative by the ICAK-USA (US chapter) this grant listed above was paid by cheque and mailed from the IC Treasurer to the ICAK-USA main office in Shawnee Mission, Kansas 66202. These funds are to support the next phase of a study, funded primarily by the ICAK-USA and designed to produce empirical evidence for the practice of a technique used by practitioners of AK called, Therapy Localization. This research is costly as it is being administered by an independant researcher and overseen by the IBORS (International Board of Researcha and Standardization).

4c (Code:) (Expenses \$ 17,065 including grants of \$) (Revenue \$ 20,922)
As stated above, the IBE, an independent board within the ICAK runs examinations in conjunction with the annual international meeting and those annual chapter meetings with enough candidates to sit for exams. The amounts above reflect revenues collected from doctors sitting for exams only and the costs of renting space for the exams and the per diems for those doctors proctoring the exams. Other operational expenses have been included in part IX, lines 13 (office expenses) and line 24a (\$420 of total website costs, \$1,500). For this fiscal year, 13 doctors passed the exams held in the above listed cities. These exams are challenging (requiring a full day to finish and include written and practical portions) and the total (13) above is just a fraction of those who sat for the exams. Form 990, part III, line 2 is a "No" response but for clarity I will repeat the description of the change initiated in the 2010 filing. This tax return includes the revenues and expenses of the IBE which keeps its own bank and paypal accounts and prior to 2010 had filed its own returns.

The IBE is a board within the ICAK working at arms length to design exam questions, organize examinations in conjunction with annual meetings and proctor and grade exams. It manages its own funds and produces an annual financial report which is incorporated into the greater report of the ICAK and included in the annual ICAK, Inc. tax return.

Form 990, part VI, line 11b: The treasurer of the ICAK, who also completes this filing, distributes a PDF copy to the executive board for review and comment prior to mailing.
