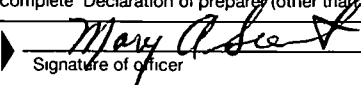

During the 2012 tax year the Medical Guild granted \$10,533 to Shands Teaching Hospital in support of hospital departments and initiatives. The Guild annually donates \$4,000 to the department of Patient & Family Resources, which uses donated funds to help patients and their families purchase basic items, like blankets, monthly medications, or medical equipment when families can not afford these items. Funds were also allocated to other departments of Shands Teaching Hospital to help fund projects like updating a waiting room for patients and families in the Pediatrics Department. Funds were also used to purchase pelvic health education equipment, a brain injury assessment and a stationary tandem cycle for use by patients at the Shands Rehabilitation Center.

Scholarship and Research Grants. The Medical Guild annually awards scholarships to Medical School students of the Colleges of the J. Hillis Miller Health Science Center at the University of Florida. Students are selected based upon criteria set forth by the colleges. During the 2012 tax year, the Medical Guild granted a total of \$14,000 in scholarships to Medical School students in the Colleges of the J. Hillis Miller Health Science Center at UF. The Medical Guild also grants funds to support graduate research in the Health Science Center. During the year, the Guild awarded a total of \$11,000 to graduate students to fund research initiatives.
