ACCORDINGLY, MANAGEMENT HAS RESTATED THE FOUNDATION'S FINANCIAL STATEMENTS AS OF APRIL 30, 2012 TO REFLECT THE CORRECTION OF ERRORS RELATED TO THE FOUNDATION'S GRANT PAYABLE ACCOUNT. SUCH RESTATEMENT RESULTED IN A \$779,826 INCREASE IN GRANTS PAYABLE. THE CORRECTION HAD NO EFFECT ON THE RESULTS OF ACTIVITIES FOR THE YEARS ENDED APRIL 30, 2013 AND 2012; HOWEVER, THE CUMULATIVE EFFECT DECREASED NET ASSETS BY \$779,826.
