I have reviewed the accompanying statements of assets and net assets-cash basis of Mass School Library Association, Inc. (a nonprofit organization) as of May 31, 2013 and 2012, and the related statements of revenues, expenses, and other changes in net assets-cash basis for the years then ended. A review includes primarily applying analytical procedures to management's financial data and making inquiries of Organization management. Based on my review, I am not aware of any material modifications that should be made to the accompanying financial statements in order for them to be in conformity with the cash basis of accounting, as described in Note A.
