matters such as derecognition, interest, penalties, and disclosure requirements. As of May

31, 2013 and 2012, the University had no uncertain tax positions requiring accrual. In

addition, the University presently is exempt from Washington State real and personal

property taxes pursuant to WAC 458-16-270 on the majority of its educational and other

noncommercial properties of the University.
