Initial year of operations of a PreK through 5th grade Classical Christian School. Our preschool consisted of 2 year old, 3 year old and 4 year old classrooms. Our grammar school consisted of kindergarten through 5th grade. We completed our first school year with 55 students enrolled in preschool and 51 students enrolled in grammar school. Our classical curriculum includes study of literature, music and art theory, mathematics, the sciences, history and various religious studies. On August 21, 2013 we commenced our second year operating a PreK through 6th grade Classical Christian School. Our beginning enrollment for this year was 51 students in PreK and 97 students in kindergarten through 6th grade.
