IT IS NOW THE SIGNATURE NATIONAL PHILANTHROPIC PROGRAM FOR ASSISTANCE LEAGUE. WICHITA'S OPERATION SCHOOL BELL HAS PROVIDED CLOTHING TO OVER 70,000 CHILDREN IN OUR PUBLIC SCHOOL SYSTEM. UNIFIED SCHOOL DISTRICT 259 SCHOOL SOCIAL WORKERS SUBMIT CLOTHING REQUESTS FOR CHILDREN. THESE STUDENTS RECEIVE NEW COATS, HATS, GLOVES, JEANS/PANTS, SHIRTS, (OR SCHOOL UNIFORMS), AND UNDERGARMENTS.
