Anderson University (University) is a comprehensive university affiliated with the South Carolina Baptist Convention offering bachelors, masters, and doctorate degrees The University is ranked in the top tier (top 23) of colleges and universities in the south and is one of "49 Schools to Watch in Amerca," by U S News & World Report The University has also been named one of "America's 100 Best College Buys" Located on approximately 270 acres in the upstate region of South Carolina near the foothills of the Appalachians, the University features a rigorous education in a supportive Christian environment The University offers 37 baccalaureate majors with 25 minors The University also offers a master of education, a master of education in administration and supervision, a master of the arts in teaching (MAT) in elementary education, a master of business administration, a master of ministry, a master of criminal justice, a master of music education, and a doctor of ministry HIGHLIGHTS OF THE YEAR ENDED 5/31/13 Anderson University continued on a nearly decade-long upward spiral of growth in the 2012-2013 academic year Enrollment at the University reached 2,912 in the fall of 2012 - marking an 80% increase in the past 8 years To accommodate the record number of students, another new residence hall was constructed, housing 102 female students Another identical hall will be constructed in 2013 and be ready for students in the fall of 2014 The fall of 2012 also saw the launch of Anderson University's new School of Nursing, which began with full classes for both the traditional Bachelor of Science in nursing and the accelerated B S N , which is designed for adults changing careers Another significant milestone for the University was its inclusion in the University Center of Greenville Anderson is the first new institution in 20 years added to the consortium of higher education institutions, entering in February with its M B A Other programs are to be added over the coming months and years, significantly increasing Anderson's presence in the Greenville area The University maintained its top tier ranking in the Annual U S News & World Report ranking of Best Colleges, and was again named as one of the "49 Up and Coming Institutions" nationally The University was named for the 6th consecutive year to the list of "America's 100 Best College Buys "Anderson University's new School of Criminal Justice became a separate school, formerly housed within the College of Adult and Professional Studies As of fall 2012, the School is housed on the first floor at 200 W Bleckly Street in Anderson (1 3 miles from the main campus) The 15,000 square foot facility includes offices and classrooms for the School of Criminal Justice Anderson University is home to The South Carolina School of the Arts The visual and fine arts programs at AU have risen in their prominence and quality over the years to the point that in the spring of 2012, the programs were branded formally as The South Carolina School of the Arts Within that School are the nationally recognized programs in musical theatre and graphic design, along with the music and visual arts programs that have become regionally recognized in their own right
