Instructional - Riverside Military Academy (RMA) is an all-boys college preparatory boarding school serving students in grades 7-12. There are approximately 460 cadets from about 29 states and 24 countries. The average class size is 14 students. This individualized attention and highly structured environment prepares the cadets for college and success in many occupational fields. Of the 96 seniors, 96 are attending/were accepted to over 119 different colleges/universities. Three cadets entered military service even though they were accepted to a college. The graduating class received \$3.2 million in collegiate scholarships to colleges and universities spanning the United States, China, and France. There are a total of 53 faculty members, and 64% of these have advanced degrees.

Athletics - RMA competes in four Junior Varsity and three Prep level sports. The Academy also competes within Region 8-AA of the Georgia High School Association (GHSA) in 12 varsity level sports. The Cross Country team was the 2012 GHSA Region 8-AA champion. The soccer team advanced to the 2013 state playoffs and won the region championship. The Tennis team was undefeated in region 8-AA and advanced to the second round of the state play-offs. The rifle team had a record of 5-3 and was the GHSA sub Area Shoot-off champion, sectional and semi-final champion.

Student Services - The vast majority of the cadets live on the 206-acre campus. The campus facilities include dormitories, classrooms, a visual and performing arts center, library, gymnasium, an extensive weight-training facility, an indoor rifle range, cafeteria and grill, book store, swimming pool, tennis courts, and lighted athletic fields. The school offers over 30 different clubs and activities for cadets to participate. The school cafeteria provides three meals a day Monday - Friday and two meals on Saturday and Sunday. They serve all of the cadets and approximately 50 members of the faculty and staff.
