HIGH MEADOWS SCHOOL'S INNOVATIVE, INQUIRY-BASED, INTEGRATED CURRICULUM EMPHASIZES LOVE OF LEARNING, CREATIVITY, MEANINGFUL CONNECTIONS, ENVIRONMENTAL RESPONSIBILITY AND EXCELLENCE. THE SCHOOL IS HIGHLY RESPECTED AND CONSISTENTLY RECOGNIZED FOR BEST PRACTICES BY MAJOR EDUCATIONAL ORGANIZATIONS, INCLUDING THE INTERNATIONAL BACCALAUREATE ORGANIZATION, SAIS AND SACS. IN SHORT, HIGH MEADOWS IS WHAT SCHOOL SHOULD BE.

AUXILIARY PROGRAMS ENCOMPASS CAMP, EXTENDED CARE AND AFTER SCHOOL ENRICHMENT PROGRAMS. AFTER SCHOOL ENRICHMENT PROGRAMS ARE INTENSIVE ACTIVITIES, SUCH AS ART, DANCE, YOGA, COOKING, MUSIC AND VARIOUS ATHLETICS THAT RUN FOR TWO 10-12 WEEK SESSIONS DURING THE SCHOOL YEAR. CAMP OFFERS CHILDREN AGES 3-15 OPPORTUNITIES FOR SELF-DISCOVERY THROUGH AGE APPROPRIATE ACTIVITIES DIRECTED AT PERSONAL IMPROVEMENT, ENVIRONMENTAL AWARENESS, AND NON-COMPETITIVE ACHIEVEMENT.
