MAPS FURTHERS ITS MISSION BY: 1) DEVELOPING PSYCHEDELICS AND MARIJUANA INTO PRESCRIPTION MEDICINES, 2) TRAINING THERAPISTS AND WORKING TO ESTABLISH A NETWORK OF TREATMENT CENTERS, 3) SUPPORTING SCIENTIFIC RESEARCH INTO SPIRITUALITY, CREATIVITY, AND NEUROSCIENCE, AND 4) EDUCATING THE PUBLIC HONESTLY ABOUT THE RISKS AND BENEFITS OF PSYCHEDELICS AND MARIJUANA.

IN FISCAL YEAR 2012-13, MAPS CONTINUED OR LAUNCHED FIVE CLINICAL TRIALS TESTING THE EFFICACY OF MDMA-ASSISTED PSYCHOTHERAPY FOR THE TREATMENT OF PTSD. ALL STUDIES ARE IN COOPERATION WITH THE US FEDERAL DRUG ADMINISTRATION AND OTHER GOVERNMENT AGENCIES INTERNATIONALLY. OUR LARGEST STUDY WILL COLLECT DATA FROM 24 VETERANS AND FIRST RESPONDERS IN CHARLESTON, SOUTH CAROLINA; 5 OF 13 TREATED SUBJECTS WERE ENROLLED AND COMPLETED IN THIS FISCAL YEAR (\$249,831). WE ARE WORKING WITH THE ISRAELI MINISTRY OF DEFENSE IN THE RECRUITMENT OF 10 SUBJECTS IN OUR NEW CLINICAL TRIAL IN BEER YAAKOV, ISRAEL. THERAPISTS ENROLLED THE FIRST 2 SUBJECTS IN THIS FISCAL YEAR (\$90,294). THERAPISTS SCREENED 3 SUBJECTS IN OUR NEW BOULDER, COLORADO STUDY INCORPORATING CLINICAL INTERNS AS CO-THERAPISTS (\$73,623). HEALTH CANADA APPROVED THE IMPORT LICENSE FOR A LOCAL PHARMACY AND MDMA WAS SHIPPED TO VANCOUVER (\$13,604) FOR THE NEW CANADIAN CLINICAL TRIAL. IN CHARLESTON, SOUTH CAROLINA, 2 SUBJECTS WERE ENROLLED IN OUR STUDY OF 3 SUBJECTS WHO HAD RELAPSED SINCE THE FIRST PILOT STUDY (\$15,741). MAPS ALSO BEGAN START-UP ACTIVITIES FOR A STUDY TESTING THE SAFETY AND FEASIBILITY OF MDMA-ASSISTED THERAPY FOR SOCIAL ANXIETY IN ADULTS ON THE AUTISM SPECTRUM (\$17,998) IN SOUTHERN CALIFORNIA. OVER HALF OUR EXPENSES FOR THESE CLINICAL STUDIES ARE FOR PERSONNEL. OTHER SIGNIFICANT EXPENSES ARE FOR SUBJECT TRAVEL AND LODGING, AND FACILITIES. IN ADDITION TO THESE DIRECT STUDY EXPENSES, EXPENSES RELATED TO MDMA STUDIES INCLUDE THE STAFF COSTS OF DEVELOPING CLINICAL AND VIDEO DATA STORAGE AND STREAMING SYSTEMS, BUDGETING, CONTRACTING, AND MEETINGS (\$49,216), OUR THERAPIST TRAINING PROGRAM (\$8,677), THE COSTS OF DEVELOPING THE TREATMENT MANUAL (\$10,260), AND THE THERAPIST ADHERENCE RATER TRAINING (\$4,829). SUPERVISORY COSTS INCLUDE MANAGING THERAPISTS, PRESENTATION OF OUR DATA AT CONFERENCES, AND SPEAKING TO THE MEDIA (\$68,859). CLINICAL RESEARCH GENERAL (\$89,448) IS PRIMARILY PERSONNEL COSTS RELATED TO DEVELOPING THE INFRASTRUCTURE NEEDED FOR OUR CLINICAL TRIALS, INCLUDING WORK WITH COMMUNICATIONS AND FUNDRAISING DEPARTMENTS, STAFF PROFESSIONAL DEVELOPMENT AND CONFERENCES, AND MANAGING VIDEO STREAMING AND STATISTICAL SOFTWARE.
