First readings are to include discussion. *Mailing of the proposed amendment to all voting members may be via regular U.S. Mail or electronic mail.*

The capitalized portions of these bylaws are required by the Association. If any of the said portion is required to be changed by the Association, the Board of Directions is empowered to the extent permitted by law to make such changes without prior notice to the membership.

Article X. Operational Policies. Operational Policies shall be adopted, amended, or rescinded with the approval of a majority of votes cast at a Board of Directors meeting. *The voting members of the Board of Directors may cast their vote via electronic mail.*

Article XI. Physical and Financial Membership Obligations Any amendment to Bylaws or Operational Policies regarding physical or financial membership obligations, projects, or fundraisers must be approved by the membership, after having Board approval. Operational Policies regarding physical or financial membership obligations, projects, or fundraisers may be amended by a majority of votes cast at any regular or special meeting of this League, provided that the proposed amendment has been mailed to all voting members at least five (5) days prior to the date of the meeting or has been read at the previous regular membership meeting. First readings are to include discussion. With no prior notice they may be amended by 2/3 of votes cast at any regular or special meeting of this League. *Mailing of the proposed amendment to all voting members may be via regular U.S. mail or electronic mail*

RATIONALE: In order to save unnecessary administrative costs of mailing a proposed amendment to the By-Laws or Operational Policies to all voting members, it is proposed that the League take advantage of the cost-effective feature of electronic mail.

RATIONALE: This motion is in conjunction with another motion to amend the By-Laws regarding the Board positions of Assistant Parliamentarian, Recording Secretary, and Administrative Assistant As membership decreases the board should also decrease to stay consistent with the membership

AMENDMENT TO MOTION: Donna moved to amend the motion to add the words "electronic and printed " The sentence which reads *"She shall maintain a complete file of minutes and records, which will remain at headquarters and may assume additional duties as assigned from time to time by the Board of Directors"* is moved to be amended to read *"She shall maintain a complete file of electronic and printed minutes and records, which will remain at headquarters and may assume additional duties as assigned from time to time by the Board of Directors."*

All members elected to the committee shall have been active members of a Junior League for two (2) or more years. c. Should a vacancy occur on the Nominating Committee, the candidate with the next highest amount of votes from the previous year's Nominating slate shall be appointed to fulfill the remainder of the unexpired term d. The Chair of the Nominating Committee will have had a minimum of one (1) year of Nominating Committee experience. She shall be selected by the Nominating Committee with the approval of the Board of Directors from among the three (3) second-year nominating Committee members. If no second year Nominating Committee members agrees to be Chair, then a member at-large with past Nominating experience shall be selected as a non-voting Chair by the \_\_\_\_\_

RATIONALE: As membership decreases and members are needed to serve on various other committees it is necessary to reduce the Nominating Committee by one (1) member.

The other item on the slate will be for the \$75.00 Fundraiser package to be given in "League Dollars" which would allow members to support the event tickets/merchandise they wish to support. League Dollars would only be in \$5.00 increments, so if an item was \$4.00, the extra League Dollar would be a donation back to the League. Members can use a combination of League Dollars and cash/credit to purchase event tickets/merchandise
- b. Spring Shift Hours (Amanda): Membership Council wanted feedback on Privileged Shifts, currently they are posted 1 week in advance (on fundraiser shifts only) so that Privileged member have more flexibility in scheduling their shifts. The Placement Committee wishes to no longer do this as they are not getting a "great response" of Privileged members signing up for these shifts. The Board discussed the importance of Privileged members having the advantage of early shift sign up, even if they do not take the opportunity The Board discussed we readdress this after the House Tour to see

how this functions over a large event, as we have not had one yet this year and in the past Privileged members have utilized this option. Amanda will discuss with the Membership Council.

- c. Annual Awards (Linda): The awards sheet has been condensed to one nomination form for ease of nominating members. Linda recalls that there was a change that needed to be made from last year's discussion, however, she cannot find record of the recommendation. The Board discussed the concern over lessening the value of awards due to the number of awards given out. Donna requested that Board members rank the importance of the awards individually and provide this information to Linda by Friday, February 8<sup>th</sup>. Lastly, it was suggested that the awards be announced throughout the meeting rather than all at once.
- d. 4K Fall Run 2013 (Donna and Tiffany): Doug Schiller has been in contact with Donna and Tiffany regarding JLS being the benefactor of funds raised from the University Park Country Club Fall Run in 2013. This would be held by University Park County Club, Fit to Run would handle registrations, and JLS would need to provide volunteers the day of the event. There is clarification needed regarding our requirement to assist in locating sponsorships; Alicia advised that a run cannot be sanctioned for runners unless it has sponsors. The country club is technically in Manatee County so JLS of Manatee needs to be consulted regarding JLS being the benefactor. Tiffany will follow up regarding further specifics and update the Board.
- e. AJLI Winter Conference (Jessica): Jessica provided a recap of the AJLI Winter Conference as well as motions which were discussed and voted upon.
