Statement of Purpose:

The purpose of the following policy and procedure is to complement the Junior League of North Harris and South Montgomery Counties, Inc to prevent the personal interests of staff members, Directors, and volunteers from interfering with the performance of their duties to the Junior League of North Harris and South Montgomery Counties, Inc and to prevent personal financial, professional, or political gain on the part of such persons

Definitions:

Conflict of Interest (also Conflict) means a conflict, or the appearance of a conflict, between the private interests and the official responsibilities of a person in a position of trust. Persons in a position of trust include staff members, officers, volunteers and Directors of the Junior League of North Harris and South Montgomery Counties, Inc

A. Disclosure

When conflict of interest or the appearance thereof, including a financial interest, is actually or potentially relevant to matters requiring action by the Board of Directors or any Council or Committee, the interested person shall promptly call this matter to the attention of the Board, Council, or Committee, the existence and nature of such conflict, or appearance thereof and such person shall not vote on the matter

Disclosure shall be made at any time when such conflict of interest, financial or otherwise, could affect the activities, finances, property, employees or services of the organization, or any matter potentially requiring Board, Council or Committee action

Any member of the Board, Council or Committee having a conflict of interest on a matter shall excuse herself from any discussions where a conflict of interest exists

B. Voting

Any member of the Board, Council or Committee having a conflict of interest on a matter shall not vote on the matter and shall not be counted in determining quorum for the vote. The minutes of the meeting shall reflect the disclosure. The fact of such relationship of interest is disclosed by that party to the board of directors and the committee that authorizes, approved, or ratifies the contract or transaction. Such authorization should be by vote or consent sufficient for the purpose without counting the votes or consents of such interested directors.
