Form 990-EZ Part I Line 20: Total \$60,655 is due to a \$2,657 decrease in total liabilities, a \$28,153 decrease in payments to independent contractors due to the completion of capital improvement projects, a \$14,396 increase in building value due to restroom and kitchen renovations and a \$15,449 increase in savings account balance due to an aggressive savings program.
