Community-Based Services Family Planning Association of Maine (FPA) provides funding, technical support and quality assurance to 46 clinics statewide in addition to operating clinics in Augusta, Belfast, Damanscottta, Farmington, Lewiston, Norway, Rockland, Rumford, Skowhegan, and Waterville serving the family planning needs of approximately 27,000 low-income Maine women, men and teens annually FPA's services are confidential, offered on a sliding fee scale, state-of-the-art, and include comprehensive medically accurate reproductive health care information to help clients make informed decisions about their reproductive health and lives gynecological exams colposcopy for evaluation of abnormal Pap tests family planning pregnancy testing and options counseling emergency contraception STD and HIV testing and treatment screenings for reproductive cancers first-trimester medication and aspiration abortion care servicesDuring 2013, 86% of our clients were low-income and a visit to one of our centers was often the only health care they received Half of all sexually active Maine teens sought counseling and services from a family planning health center and many of these young people continue to use our trusted services through adulthood In 2013, 5,379 teens were provided the care they needed to prevent unintended pregnancy and the spread of sexually transmitted diseases According to 2005 data (the most recent data available), Maine's teen pregnancy rate is 3rd lowest in the nation From 1998 to 2005, Maine's teen pregnancy rate dropped an amazing 48%

Education and Research Projects In 2013, the FPA continued to provide Maine teens with sexual health information that is medically accurate and age appropriate Designed with input from Maine teens, www.mainehealth.org provides sexual health information, a guide to Maine's family planning clinics, and an interactive place to get answers to their sexual health questions The FPA's text messaging service, AskMTH, allows teens to use their cell phones to text anonymous questions and get answers from a trained family planning professional In 2013, our text line fielded 314 questions from 94 different teens, indicating that teens find the service useful and return to it again and again During FY2013, our teen website received and answered 104 questions from Maine teens In 2013, Family Planning Association hired an Outreach and Marketing Coordinator to facilitate and strengthen partnerships between the FPA and other local and statewide organizations Outreach collaborations work to reinforce and facilitate referrals to Family Planning clinics and other services, provide shared learning opportunities for FPA and partner agency staff, and solidify FPA as the leading resource for reproductive health care services and education in Maine Locally, connections have been made with sexual assault, domestic violence, social service providers and case workers, and community-based public health programs, statewide collaborators include the Maine Coalition Against Sexual Assault, Maine Families home visitation program, MaineCare services, The Horizon Program (providing care and services for Mainers with HIV/AIDS), and Health Affiliates Maine (a network of behavioral health providers) Since January of 2013, over 80 in-person connections, some with formalized partnership agreements, have been made through the Outreach program During FY2013, through the FPA's Teen Pregnancy Prevention Program, Prevention Coordinators worked with educators in 17 schools and community-based organizations statewide to deliver a variety of evidence-based, comprehensive sexuality education curriculums focused on preventing HIV/STDs and pregnancy, reaching 1,053 youth In order to sustain sexuality education efforts, we continue to provide training and professional development through web-based sessions, in-person trainings and statewide conferences In the past school year (2012-13), a total of 257 educators from schools, youth-serving organizations and government agencies attended these training opportunities During FY2013, the FPA's Teen Pregnancy Prevention Program also continued its work through the federally funded Personal Responsibility Education Program (PREP), partnering with Jobs for Maine's Graduates (JMG) to deliver evidence based programming During the 2012-13 school year 310 students participated in the All4You! curriculum in 13 high schools located in Maine communities with high teen pregnancy rates Evaluations showed increased knowledge and improved attitudes around HIV/STDs, pregnancy prevention, and behaviors that put teens at risk and preventive measures like abstinence, birth control and condom use Similar to our community-based services, funding for the FPA's education and research projects is provided by State and Federal agencies (that also monitor program operations and outcomes), foundation grants and other restricted revenues

Agency and Mission-Related Projects Since 1971, the FPA's Public Affairs staff has worked to protect the reproductive rights of all Maine citizens The Family Planning Association is founded on the premise that Maine women and teens must have access to comprehensive reproductive health care and information in order to control their reproductive lives The FPA Public Affairs efforts are designed to promote and protect programs and services statewide to ensure affordable access to family planning In FY2013, the Family Planning Association of Maine focused much of its advocacy efforts on defeating legislation aimed at restricting access to reproductive health care in Maine Despite the fact that Maine has repeatedly demonstrated its support for reproductive privacy in recent years, bills limiting this privacy continue to appear before the Maine Legislature, forcing the FPA and our coalition partners to dedicate considerable time and effort to defeat them Each new legislative session brings new legislators who require education to dispel myths about reproductive health care and reproductive rights, and to help them recognize reproductive health care as basic health care for women, rather than simply a political issue With the assistance of many coalition partners, the FPA was able to again defeat every bill that threatened reproductive health care in the 2013 legislative session We continue to rely on a strong network of pro-choice, pro-family planning grassroots activists who communicate very powerfully with their elected representatives, and will continue to be vigilant in protecting and expanding access to the full range of reproductive health care for all women, men and teens in Maine Private contributions and agency-endowed resources fund these projects No public funds are used

The federal Centers for Medicare and Medicaid Services (CMS) provided incentive funds to eligible providers to meet compliance guidelines associated with the Health Information Technology for Economic and Clinical Health Act (HITECH) Also called "meaningful use" funds, these awards allowed the FPA to focus on technology and training needs to adopt a successful Electronic Health Record (EHR) program and be able to use EHR to meet federal health policy priorities
