THE SCHOOL CELEBRATED THE ENROLLMENT OF ONE MIDDLE AND ONE UPPER SCHOOL MALONE SCHOLAR, THE RESULT OF EARLIER FUNDING PROVIDED BY OUR SPRING 2012 SELECTION AS NEW HAMPSHIRE'S FIRST JOHN J. MALONE FAMILY FOUNDATION PARTNER SCHOOL. THE PURPOSE OF THIS PARTNERSHIP IS TO PROVIDE ACCESS TO GIFTED AND TALENTED STUDENTS NEW TO THE DERRYFIELD SCHOOL AND WAS ACCOMPANIED WITH A \$2,000,000 ENDOWMENT AWARD FOR FINANCIAL AID FOR THAT SPECIFIC PURPOSE.
