Background and History From its inception back in 1890 as The Home for Friendless Women, Lund, a nonprofit statewide organization, based in Burlington and South Burlington, Vermont, has worked to improve the lives of women and children, evolving over the years to meet the changing needs of society, all the while, staying true to the mission of helping children thrive Lund helps children thrive by empowering families to break cycles of poverty, addiction and abuse Lund offers hope and opportunity to families through education, treatment, and family support Originally more of a maternity home and adoption agency, Lund has transformed into a nationally recognized, comprehensive treatment center family support agency, and nationally recognized statewide adoption program Lund offers an array of integrated services in response to the needs of pregnant or parenting women, their children and family members Lunds treatment programs are gender-specific, trauma-informed, and family-centered
