and approximately 135,000 student. Partnering with businesses with trucks and drivers already on the road, Classroom Central also delivered \$555,873 worth of supplies to schools on the furthest fringes of CC's footprint through the Mobile Free Store. Through "Backpacks" Classroom Central supplied fully stocked backpacks worth \$160,000 to students in 6.5 schools in the Charlotte Region. In January 2013 we established a new direct-to-schools distribution process of getting school supplies to children most in need. Through this pilot project with Charlotte-Mecklenburg Schools, we provided five core school supplies to teachers via a newly developed online ordering system. Teachers are able to identify the number of students that come unprepared to learn in their classrooms, whether they attend a high needs school or low needs school. Teachers are then able to select among the most-often used categories of school supplies, order them online, obtain approval from their school's Principal, and then receive items as they are delivered through existing CMS transportation modes. This efficient method of getting supplies directly to students who most need them, when and where they use them, is the first of its kind in the United States. Operating in 17 schools, this pilot program impacted 7,379 students living in poverty, 3,367 whose needs were previously unmet.
