	United Way of North Central Massachusetts made \$1.8 million in grants and distributions during the year. In addition to its grantmaking, United Way is focused on mobilizing the caring spirit of the community through its volunteer center. The goal of these grants and distributions, and the work of our volunteers, is to provide immediate assistance to those in need, while creating a community where everyone has the opportunity for a better life. United Way creates these opportunities through its work in the areas of education, income and healththe building blocks for a better life. United Way's priorities include youth development and education, substance abuse and domestic violence, and emergency food and shelter. In addition to funding 39 programs, which delivered over 120,000 health and human services, through local nonprofits, United Way also has community initiatives that include: United Way Youth Venture, which inspires and invests in teams of young people, to design and launch their own lasting social ventures. The program is in 11 school systems and reached over 2,500 students in the past year. Dolly Parton Imagination Library is the newest program United Way launched. It is a preschool literacy program that provides children with a new, FREE, age-appropriate book each month from birth until their 5th birthday, regardless of socioeconomic status. This program ensures that children have quality books in the home in their most developmental years. Any child living in Ayer, Shirley, Fitchburg, Leominster, Gardner, Winchendon or Templeton may sign up for the program. The program is sending books to over 1,200 children every month. United Way Community Builders is a volunteer center, which promotes volunteernism through outreach efforts and its interactive website, www.community-builders.net. Last year, over 14,841 hours were donated, impacting nearly 90,000 residents. One of the initiatives included United Way volunteers packaging over 45,000 meals that were distributed to 13 food pantries in North Central Massachusetts. We also host one of the largest Day of Caring events in the state. Over 2,500 volunteers spent the day helping nonprofits complete over 62 projects that wouldn't normally get done because of the lack of personnel and resources. Mass 2-1-1, which is sponsored by United Way, is a free information and referral service that connects residents to health and human services in the community. Over 6,500 local residents have used the service. FamilyWise affords prescription discounts and savings to local residents that are uninsured or underinsured, saving area residents over \$690,000 since the program was launched locally. United Way's Supplemental Basic Needs Fund delivers food and heating assistance as additional needs are identified throughout the year. This past year over 4,800 individuals received assistance. United Way's Emergency Shelter Fund provides shelter to homeless individuals during extreme winter events and situations. Over 84 individuals were helped with 384 nights of lodging. United Way once again hosted its annual heating forum, which provides critical information to nonprofit agencies on the various heating assistance programs. United Way also helped promote the Volunteer Income Tax Assistance (VITA) program previously known as EITC, which provides no-cost tax preparation to people who work and have low- to moderate wages. This past year, area residents received almost \$1,000,000 in tax refund credits through this program.

	United Way Youth Venture (UWYV) reaches out to young people and inspires them to take initiative and make a positive, lasting change in their communities. When young people learn early in life that they are powerful and capable of leading social change,, they are more likely to continue to lead throughout their lives. UWYV is a three-way partnership between Ashoka's Youth Venture, Mount Wachusett Community College and United Way of North Central Massachusetts. This program is in 17 school systems and has reached over 2,264 students in the past year.

	A special fund-raising campaign was initiated a couple of years ago in response to the increased need for Safety Net services. This campaign proved critical to our being able to respond to a stubbornly high unemployment rate. One hundred percent of the all funds raised were granted to agencies that had the network capabilities to get food and energy assistance to those most in need. This past year 7,004 individuals received assistance.
