The Program maintains high academic standards and dedication to a sound liberal education for which its sponsoring institutions are known. Each year students are accepted to study the Japanese language intensively and take courses in English or Japanese. Students can apply for Cultural Activity (25 recipients in the 2012-2013 academic year), Spring Field Trip (25 recipients in the 2012-2013 academic year), Research (six recipients in the 2012-2013 academic year), and Internship (one recipient in the 2012-2013 academic year) grants to enhance their experience of the Japanese culture and help them pursue independent research projects outside of the regular curriculum. Japanese students also have a chance to attend the US for studies (two students in the 2012-2013 academic year).
