Unanimous Written Consents Regarding Trust Changes and Clarifications and Agency Designation as Trust Agent

WHEREAS, the HEFA Charitable Institutional Trust (the "Trust") is a declaration of trust most recently amended in its entirety on October 15, 2009, by the then-serving trustees and further amended by the Current Trustees (defined below) by Consents dated September 24, 2010;

WHEREAS, the trustees of the Trust as of the date hereof are Gregory P. Bialecki, as Chairman of the Massachusetts Development Finance Agency ("MassDevelopment"); Gerald D. Cohen, as Vice Chairman of MassDevelopment; and Teresa M. Patten, as Secretary of MassDevelopment (collectively, the "Trustees");

WHEREAS, the Trustees wish to amend the name of the Trust to "MassDevelopment/HEFA Trust";

WHEREAS, the Trustees wish to consent to clarification of the Trust regarding the amount of earned interest and Trust principal that may be used annually for the purposes set forth in the Trust;

WHEREAS, paragraph 5.4(h) of the Trust authorizes the trustees of the Trust to retain agents and other advisors and on May 9, 2006, the then-serving trustees of the Trust declared that, in lieu of hiring employees or engaging consultants of their own, they wished to avail themselves of the resources, including staffing, information, contacts, and expertise of HEFA, by designating HEFA as their agent for purposes of administration of the Trust as set forth in a resolution adopted on that date;

WHEREAS, pursuant to Chapter 240 of the Acts of 2010, on October 1, 2010, HEFA was merged with and into MassDevelopment, and the rights, powers, duties and property of HEFA on and after such date were to be exercised, performed, owned, and held by MassDevelopment;

WHEREAS, to reflect this merger, the Current Trustees confirmed and acknowledged that, effective October 1, 2010, MassDevelopment has all of the agency powers that HEFA previously possessed pursuant to the May 9, 2006, agency designation and acknowledged the confirmation by the MassDevelopment Board of Directors that MassDevelopment continue to serve that agency function;

WHEREAS, the Current Trustees wish to consent and confirm that MassDevelopment, as agent for the Trust, has the authority to approve grants and loans to be made by the Trust for the purposes set forth in the Trust to those parties eligible for funding from the Trust; to take all actions to fund such grants and loans; and to execute and enforce grant and loan documentation;

WHEREAS, the Trustees wish to further confirm that MassDevelopment, as agent for the Trust, may use Trust funds to acquire existing loans, including loans made by MassDevelopment from its general funds, to become assets of the Trust and shall administer such loans and enforce them the same as loans made directly from Trust funds;

NOW THEREFORE:

1. The Trustees hereby consent to the following and ratify any actions taken prior hereto with regard to the following:
 - a. The Current Trustees hereby consent and change the name of the Trust to "MassDevelopment/HEFA Trust."
 - b. The Current Trustees of the Trust hereby consent to the following clarification regarding the use of Trust assets consisting of earned interest and Trust principal: that 100% of the interest earned on the Trust's principal in a fiscal year and up to 10% of the cash balance of the Trust's principal not committed to any other fundings or purposes as of June 30 of such fiscal year may be used in the next succeeding fiscal year for purposes allowed under the Trust, provided that if, at the end of such fiscal year, not all of the available interest and principal has been used, the balance may be carried forward for use in the next succeeding fiscal year.
 - c. The Current Trustees of the Trust hereby ratify and confirm the tasks of MassDevelopment as the Trust's agent set forth in the Trustees Consent dated November 10, 2010, which are listed on Attachment A hereto, and consent to and ratify the additional tasks set forth below:
 - (i) MassDevelopment shall review applications from applicants for grants and loans from the Trust assets and shall have the authority to approve such grants and loans to parties eligible for funding from the Trust using the policies and procedures that it uses for approval of grants and loans made by MassDevelopment on such terms as MassDevelopment as the Trust's agent finds to be beneficial to the Trust and in compliance with the Trust's purposes; to take all actions necessary to fund such grants and loans; to execute and enforce grant and loan documentation in the name of the Trust; and to take all other actions required in relation to such grants and loans to implement this Consent.
 - (ii) MassDevelopment, as agent for the Trust, shall have authority to use Trust funds to acquire, as assets of the Trust, existing loans made by other entities, including, without limitation, MassDevelopment loans made from its general funds, provided such loans are for purposes set forth in the Trust and were made to parties eligible for funding from the Trust, as determined by MassDevelopment, as agent for the Trust.
2. Section 5.3 (d) of the Trust provides that anyone dealing with the Trust property may rely on a writing signed by any trustee as to the trustee's authority to act on behalf of the Trust

and the Trustees hereby affirm that anyone dealing with Trust property or a Trust grant or loan can rely on the signature of a MassDevelopment officer as to MassDevelopment's authority to deal with the Trust's property, grant, or loan and if requested any trustee singly can sign a certificate as to the existence of such authority.

3. Any delegation or appointment made hereunder may be fully or partially revoked by the current Trustees at any time in writing delivered to MassDevelopment pursuant to their fiduciary powers under the Trust. The revocation shall be effective upon delivery of such revocation to MassDevelopment or refusal of delivery, as the case may be.
4. This instrument may be executed in any number of counterparts, each of which shall for all purposes constitute one instrument which is binding on all of the parties hereto.

MassDevelopment tasks as agent for the Trust as set forth in the November 10, 2010, Trustees Consent.

- a) MassDevelopment shall serve as the Trust's agent to manage the affairs of the Trust, including, without limitation, all bookkeeping functions, maintenance of the general ledger, the investing of the Trust's assets in accordance with an approved investment policy, and the annual audit process.
- b) In addition, MassDevelopment, as agent, is directed to consider, develop, and recommend to the Trust one or more programs and other purposes for the utilization of the Trust's assets. Each such program shall be consistent with the purposes and terms of the Trust and shall be subject to criteria recommended by MassDevelopment and approved by the Trust.
- c) MassDevelopment shall report to the Trust on a regular basis and shall keep complete and accurate records with respect to all matters managed by MassDevelopment on behalf of the Trust, including all transactions under any program or programs for the utilization of the Trust's assets. MassDevelopment may engage outside consultants and legal advisors to assist in carrying out its agency role and effectuating any such program or programs.
- d) MassDevelopment shall be paid by the Trust for its administrative overhead and reimbursed for any other consultant or legal fees and expenses related to carrying out its role as agent hereunder.
