The License Plate Program grants funds received from sales of the "I'm Animal Friendly" license plate to non-profit humane organizations and municipal animal control agencies in the Commonwealth that provide spaying and neutering services for cats, dogs and rabbits. In this year's grant cycle 29 organizations received funding. The program benefits the community, the Commonwealth and, of course, the animals. Since the program's inception in 2004 over a million dollars has been granted, enabling tens of thousands of animals to receive services that both improve their health and reduce the population of unwanted pets.

4b (Code: ) (Expenses \$ 34,780. including grants of \$ 598.) (Revenue \$ 0.)

Donations to the RMV License fund is for grants given by the organization to support spay/neuter efforts in Massachusetts and help to reduce the number of homeless animals in the state. The AniMatch program assists animal welfare organizations across the state in transferring dogs that are in need of placement from organizations with limited resources to those that have a better ability to find the pets a "forever home." The Spay Worcester task force provides spay neuter and rabies vaccinations to free roaming cats in the city of Worcester, and the Pit Bull task force promotes spay and neuter programs for Pit Bull Terriers and works to improve their image as adoptable pets.

4c (Code: ) (Expenses \$ 17,318. including grants of \$ 34,270.) (Revenue \$ 8,631.)

The Spay Worcester task force works to reduce the population of free-roaming cats in The city of Worcester MA through spay neuter services and public education. The focus of this task force is to provide basic medical care (spay/neuter and vaccinations) for stray cats through targeted trap-neuter-return. The task force also seeks to provide these same services for free-roaming cats that have human homes (aka "owned" cats). Spay Worcester also provides a food bank for low-income cat owners and caretakers by partnering with other organizations. The task force has spayed/neutered and vaccinated over 1,000 cats in the task force's first two years of operation.
