Tobacco-use Prevention: The SCTFC approaches tobacco-use prevention through a comprehensive control methodology, commonly referred to as "best practice". For the current year, the SCTFC accomplished the following in pursuit of this methodology: 1) Fielded an estimated 200 phone calls from citizens interested in tobacco cessation services; referred those callers to the state's Tobacco Quitline (800-QUIT-NOW); 2) Advised over 3,000 database members on regional tobacco-use prevention activities across SC; 3) Provided technical and programmatic assistance to four community coalitions, and 4) Provided educational services to municipal leadership as requested by city/town/county managers or executives. The goal of this program is to reduce tobacco-use prevalence and dependence in SC. The objective is to reduce smoking rates by 1% per prog yr for 10 yrs; or for another period of time as determined by interested stakeholders.

Support Healthy South Carolina Initiative - The organization supports the Healthy South Carolina Initiative's efforts that maximize health impact through prevention, advance health equity, eliminate health disparities and expand the evidence base for local policy and environmental and infrastructure changes that impact health. These efforts are aimed at reducing death and disability due to tobacco use by 5 %, reducing the rate of obesity through nutrition and physical activity intervention by 5% and reducing death and disability due to heart disease and stroke by 5%. As a partner in these efforts, SCTFC leads the Tobacco-Free Living strategy section of the Community Transformation Grant implementation plan. The SCTFC 1) Made 38 grants to local organizations and coalitions throughout the state aimed at reducing tobacco rates at the community level; 2) Held a grant making webinar to educate lay applicants on the grant program and service deliverables, and 3) Established contractual relationships with two organizations to increase reach into South Carolina's rural communities.
