The Yale University Elizabethan Club Corporation is an organization operated solely for the benefit of and in connection with Yale University, an organization described in Section 170(b)(1)(A)(11) of the Internal Revenue Code of 1954 as amended.

The Corporation was formed in 1911, and its purposes include the promotion among its membership and in the Yale community of a larger appreciation of literature. Membership is drawn almost entirely from the Yale community, and includes faculty, students and alumni who are interested in the serious discussion of literature. Distinguished scholars and authors from outside the Yale community are sometimes elected to honorary membership.

The principal assets in which the Corporation has an interest are its building, located at 459 College Street, on the Yale campus in New Haven, which houses the library and serves as a meeting place for conversations and discussions relating to literary topics; its endowment fund, which is held by Yale University in trust for the Corporation; and its library, containing a number of very valuable books and pamphlets known as "The Elizabethan Club Collection", ownership of which is vested in Yale University and is deposited in the Corporation's building and held for use by scholars and others in the Yale community. A separate fund is held by the Yale University Press, for publications of a scholarly nature under the direction of the Corporation.

The Articles of Association provide that the Corporation may, upon the affirmative vote of two-thirds of its members, convey all of its property to Yale University; further provide that if the Corporation shall be dissolved or its corporate existence be terminated, all of its property shall immediately vest free and clear of any trust in Yale University; further provide that the Corporation may not sell, convey or encumber any of its property without the consent of Yale University; and further provide that the Articles of Association may not be amended without the consent of Yale University.
