THE BOARD WILL HOLD AN EXECUTIVE SESSION (WHERE NO STAFF IS PRESENT) TO REVIEW THE ABOVE MATERIAL WITH SALARY SURVEYS, INFORMATION FROM 990'S OF COMPARABLE ORGANIZATIONS AND INFORMATION FROM TRADE GROUPS IN CONSIDERING THE WAGE OFFERED TO THE CEO.
