Gemma E Moran United Way Labor Food Center According to a U S Census Bureau study, more than 19,000 people in southeastern Connecticut are living below the poverty level In addition, one out of every five children is food insecure, meaning, they do not know where their next meal may come from The Gemma E Moran United Way/Labor Food Center is making a difference for the hungry in southeastern Connecticut The Food Center provides food and household items to more than ninety free food distribution sites throughout New London County These sites include shelters, food pantries, after-school programs, day care centers, community meal sites, and programs for the elderly Last year, the Food Center distributed 2,175,217 pounds of food which in turn helped provide the equivalent of 1,812,681 meals and snacks, at no cost, to those in need throughout New London County During the Thanksgiving holiday last year, the Food Center distributed 1,910 turkeys along with traditional side dishes to community meal sites and for baskets for families In addition to providing operating expenses, United Way also helps to mobilize groups of volunteers to help sort and organize food at the Food Center throughout the year as well as encouraging local businesses and organizations to run food drives to help keep the shelves full

Community Wellness United Way of Southeastern Connecticut supports 26 of programs located in New London County that promote and provide Community Wellness Together, these programs improve the physical, mental, and emotional health of individuals and families, eliminating personal barriers and improving the quality of life United Way's partner programs in Community Wellness improve access to primary medical, dental and behavioral health, provide education and resources to build healthy environments for at-risk families, provide access to legal services, and provide services for seniors and people with disabilities to maintain their independence One example of a positive result from a Community Wellness partner is from the United Community and Family Services Dental Health Program, which aims to improve people's oral health Dental health and preventive care is critical to the overall health of individuals, and can avoid more costly medical issues later on The program offers full dental services by licensed dentists and hygienists for people of all ages including cleanings, fluoride, x-rays, fillings, root canals, crowns and bridges, dentures, extractions, night guards and sports guards Insurance is accepted but the program offers a sliding fee scale for those without insurance Of the 6,439 individuals served in the Dental Health Program last year, 92% maintained or improved their periodontal status and 82% maintained or reduced their dental decay
