Connecticut Legal Services provides civil legal representation and counseling to help low-income individuals (adults and children) and families obtain just legal solutions to serious life problems. We assist our clients to use the law to help themselves climb out of poverty, improve their lives, and build better futures for their children. Our areas of specialty include domestic violence/family, homelessness/housing, public benefits and employment, education and juvenile law, elder rights, and disability law. During the 2012/2013 fiscal year, CLS advocates provided assistance to 3,548 low-income households consisting of 8,057 individuals, including 3,125 children. Advocates also worked on 2,728 active cases that were brought over from the prior fiscal year. In addition, 146 outreach/community legal education events were held throughout our service area, reaching over 6,300 individuals. Over 3,600 legal educational pamphlets were distributed at these events.

During the 2012/2013 fiscal year, Connecticut Legal Services received a total value of \$223,646 in donated services to support the work described above. In addition, Connecticut Legal Services received donated office equipment with a market value of \$100 during the 2012/2013 fiscal year.
