Latino Project-provides for the improvement of behavioral healthcare for bilingual Latinos and the permanent expansion and enhancement of culturally relevant treatment alternatives for the monolingual population of Connecticut. Tobacco Cessation Program-provides education and support services to adults with serious mental illness interested in reducing or quitting their tobacco use.
