Notes to Financial Statements June 30, 2013

1. Organization

The Volunteer Health Program, Ltd. ("VHP") provides volunteer eye care in the Dominican Republic through contributions of money and donated medical supplies and equipment. Nurses provide examinations and eye wear for those in need. VHP was formed with the primary goal of improving people's healthcare by providing visual health services.

VHP is qualified as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code and, accordingly, is not subject to federal income taxes. The Internal Revenue Code has qualified VHP as an organization that is not a private foundation as defined in Section 509(a) of the Internal Revenue Code.

2. Summary of Significant Accounting Policies

Use of Estimates

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. "GAAP") which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Classes of Net Assets

Net assets are classified based on the existence or absence of donor-imposed restrictions. VHP's net assets are neither permanently nor temporarily restricted by donor-imposed restrictions and are classified as unrestricted.

Fair Value of Financial Instruments

VHP follows U.S. GAAP guidance on fair value measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

Investments Valuation

Investments are carried at fair value.

2. Summary of Significant Accounting Policies (*continued*)

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses are included in the determination of income.

Contributions

All contributions are considered available for unrestricted use, unless specifically restricted by the donor or subject to other legal restrictions. VHP's policy is to report as unrestricted support, contributions with donor-imposed restrictions when the restrictions are met in the same year that the contributions are received.

In-kind and Non-Cash Contributions

In-kind contributions of services are recorded in the financial statements if those services create or enhance non-financial assets or require specialized skills provided by individuals possessing those skills and would typically be purchased if not provided by donation. In-kind and non-cash contributions of services and goods are reported as income and expense at fair market values for the services rendered or goods received.

Accounting for Uncertainty in Income Taxes

VHP recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that VHP had no uncertain tax positions that would require financial statement recognition or disclosure. VHP is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to June 30, 2010.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is December 5, 2013.

3. Investments

At June 30, 2013, investments consist of mutual funds valued using Level 1 inputs.

4. In-kind and Non-Cash Contributions

VHP receives donations of eyeglasses, medical supplies and medications from various corporations. The total of these non-cash contributions for the year ended June 30, 2013 was \$284,421. Professional services are donated to VHP for various medical surgeries, anesthesiology and eye examinations. The total of these in-kind donated services for the year ended June 30, 2013 was \$692,350.
