Demos Ideal Elections team works to strengthen our democracy and increase access to the ballot for our multi-origin, multi-racial citizenry. Our work to achieve this includes increasing voter registration of low-income people by enforcing the public agency provisions of the National Voter Registration Act, expanding the freedom to vote by advancing pro-voter election reforms, anchored by Same Day Registration, shifting popular opinion to reverse or halt measures that restrict voting rights, and addressing structural barriers to fair redistricting and representation.
