THE AMERICAN FOUNDATION FOR THE BLIND (AFB) IS A NATIONAL NONPROFIT THAT EXPANDS POSSIBILITIES FOR PEOPLE WITH VISION LOSS. AFB'S PRIORITIES INCLUDE BROADENING ACCESS TO TECHNOLOGY, ELEVATING THE QUALITY OF INFORMATION AND TOOLS FOR THE PROFESSIONALS WHO SERVE PEOPLE WITH VISION LOSS, AND PROMOTING INDEPENDENT AND HEALTHY LIVING FOR PEOPLE WITH VISION LOSS BY PROVIDING THEM AND THEIR FAMILIES WITH RELEVANT AND TIMELY RESOURCES. AFB'S WORK IN THESE AREAS IS SUPPORTED BY THE STRONG PRESENCE THE ORGANIZATION MAINTAINS IN WASHINGTON, DC, ENSURING THE RIGHTS AND INTERESTS OF PEOPLE WITH VISION LOSS ARE REPRESENTED IN OUR NATION'S PUBLIC POLICIES. IN ADDITION TO ITS NEW YORK CITY HEADQUARTERS AND PUBLIC POLICY CENTER IN WASHINGTON, DC, AFB MAINTAINS OFFICES IN ATLANTA, DALLAS, AND HUNTINGTON, WV. AFB IS ALSO PROUD TO HOUSE THE HELEN KELLER ARCHIVES AND HONOR THE OVER FORTY YEARS THAT HELEN KELLER WORKED TIRELESSLY WITH AFB TO EXPAND POSSIBILITIES FOR PEOPLE WITH VISION LOSS.

	KNOWLEDGE BUILDING & INFORMATION DISSEMINATION IN FY13, AFB STRENGTHENED ITS PROGRAM OUTREACH THROUGH ENHANCED MARKETING OF ITS NEWLY DESIGNED WEBSITE, WITH SPECIAL FOCUS ON SEARCH ENGINE OPTIMIZATION, DIRECT EMAIL MARKETING, ADVERTISING, LINK-BUILDING, VISITOR ENGAGEMENT, AND SOCIAL MEDIA OUTREACH. AFB PURSUED AND WAS AWARDED A 2012 HEALTHCARE LEADERSHIP AWARD IN THE OVERALL WEBSITE CATEGORY/CONSUMER DISEASE-FOCUSED SITE AFB'S CAREERCONNECT PROVIDES COMPREHENSIVE EMPLOYMENT INFORMATION, JOB READINESS SKILLS, PEER AND MENTOR SUPPORT, AND SELF-ADVOCACY GUIDANCE TO EMPOWER JOBSEEKERS WITH VISION LOSS. IT IS THE NATION'S LEADING ONLINE PROVIDER OF EMPLOYMENT AND JOB SEARCH INFORMATION DEVELOPED SPECIFICALLY FOR THE VISION LOSS COMMUNITY. IN FY13, NEW TRAINING COURSES - "WORKING WITH JOB SEEKERS WHO ARE BLIND OR VISUALLY IMPAIRED," AND "LESSON PLANS FOR TEACHERS AND PROFESSIONALS" - WERE ADDED TO CAREERCONNECT. NEARLY 400 TEENS RECEIVED TRAINING AND INSPIRATION RELATED TO NAVIGATING THE EMPLOYMENT PROCESS THROUGH 13 "TEEN EMPLOYMENT WORKSHOPS" CONDUCTED BY CAREERCONNECT STAFF. THE SITE NOW FEATURES OVER 100 INSPIRATIONAL STORIES ABOUT MENTORS AND OTHER PERSONS WITH VISION LOSS WHO HAVE ACHIEVED SUCCESS IN THEIR WORKING LIVES UNDER THE "OUR STORIES" SECTION. THE PROGRAM CONTINUES TO GROW WITH VISITORS UP BY 20% AND PAGES VIEWED UP 11%, WHILE OVER 16,000 PEOPLE HAVE REGISTERED TO USE THE SITE AND NEARLY 2,500 BLIND OR VISUALLY IMPAIRED MENTORS HAVE SIGNED UP TO OFFER GUIDANCE. VISITORS POSTING TO THE MESSAGE BOARDS INCREASED BY 52%. FAMILYCONNECT, CREATED BY AFB AND THE NATIONAL ASSOCIATION OF PARENTS OF CHILDREN WITH VISUAL IMPAIRMENTS (NAPVI), PROVIDES A VIRTUAL LIFELINE TO CONNECT PARENTS AND FAMILIES TO RELIABLE INFORMATION, RESOURCES AND EACH OTHER, TO SUPPORT RAISING CHILDREN WITH VISION LOSS FROM BIRTH TO SUCCESSFUL ADULTHOOD. THE PROGRAM CONTINUED TO DEMONSTRATE CONSISTENT GROWTH FOR A MATURE WEB SITE OF FIVE YEARS, WITH VISITORS INCREASING BY 23%, VISITS INCREASING BY 15%, AND PAGE VIEWS UP BY 2%. NEARLY 5,000 PEOPLE HAVE REGISTERED TO USE FAMILYCONNECT. DURING FY 2013, FAMILYCONNECT ADDED FIVE PROFESSIONALLY-HOSTED MESSAGE BOARDS TO PROVIDE EXPERT ADVICE TO PARENTS, ADDED A SECOND PARENT BLOGGER, AND RECRUITED PARENTS FOR SPECIAL INTEREST BLOGS. AFB'S VISIONAWARE INSPIRES AND EMPOWERS PEOPLE NEW TO VISION LOSS TO CARRY ON FULL LIVES BY PROVIDING HOPE, HELP AND CONNECTION TO SUPPORT AND SERVICES FOR THEMSELVES AND THEIR FAMILY MEMBERS. LAUNCHED IN JUNE 2012 WITH SUPPORT FROM THE READER'S DIGEST PARTNERS FOR SIGHT FOUNDATION, VISIONAWARE EXPERIENCED TREMENDOUS GROWTH WITH A 45% INCREASE IN VISITORS, 46% INCREASE IN VISITS AND 19% INCREASE IN PAGES VIEWED. SIGNIFICANT CONTENT WAS ADDED OR REVISED WITH 135 NEW OR UPDATED ARTICLES, 152 BLOG POSTS, AND A NEW SECTION FOR VETERANS WITH VISION LOSS. AN IMPRESSIVE 25,000 VISITORS INTERACTED THROUGH THE SITE'S MESSAGE BOARDS WHILE VISIONAWARE TWITTER FOLLOWERS INCREASED TO 6,050, AND FACEBOOK "LIKES" WERE UP 106%. ALL TOLD, VISIONAWARE SERVED 466,000 UNIQUE VISITORS IN FY13, WITH THE NUMBER OF PAGES VIEWED TOTALING OVER 1.1 MILLION FOR THE YEAR. AFB PRESS, AFB'S PUBLISHING ARM AND LEADING PUBLISHER IN THE FIELD OF BLINDNESS AND VISUAL IMPAIRMENT, RELEASED TWO NEW RESOURCES FOR PROFESSIONALS SERVING PEOPLE WHO ARE BLIND OR VISUALLY IMPAIRED: PHYSICAL EDUCATION AND SPORTS FOR PEOPLE WITH VISUAL IMPAIRMENTS AND DEAFBLINDNESS; FOUNDATIONS OF INSTRUCTION AND THE ART AND SCIENCE OF TEACHING ORIENTATION AND MOBILITY TO PERSONS WITH VISUAL IMPAIRMENTS. ONE OF AFB PRESS'S FIRST E-BOOK TITLES, REACH OUT AND TEACH: HELPING YOUR CHILD WHO IS VISUALLY IMPAIRED LEARN AND GROW, EARNED THE QED (QUALITY, EXCELLENCE, DESIGN) SEAL FROM DIGITAL BOOK WORLD, SIGNALING TO E-BOOK READERS OR APP USERS THAT THE TITLE WILL RENDER WELL REGARDLESS OF THEIR PREFERRED READING FORMAT. AFB'S JOURNAL OF VISUAL IMPAIRMENT & BLINDNESS (JVIB), THE INTERNATIONAL PEER-REVIEWED JOURNAL OF RECORD IN THE BLINDNESS FIELD, DELIVERS CURRENT RESEARCH AND BEST PRACTICE INFORMATION, COMMENTARY FROM AUTHORITATIVE EXPERTS ON CRITICAL TOPICS, AND A CALENDAR OF IMPORTANT EVENTS. IN FY13, JVIB BECAME THE OFFICIAL MEMBERSHIP JOURNAL OF THE ASSOCIATION FOR EDUCATION AND REHABILITATION OF THE BLIND AND VISUALLY IMPAIRED (AER), WITH ALL AER MEMBERS BEING GRANTED ACCESS TO A PREMIUM-LEVEL SUBSCRIPTION, INCREASING JVIB READERSHIP FROM APPROXIMATELY 1,500 TO 4,500. JVIB ALSO MOVED TO AN ONLINE-ONLY PUBLICATION IN JANUARY 2013, WITH TIERED SUBSCRIPTION LEVELS OFFERING VARYING DEGREES OF ARCHIVAL AND E-BOOK ACCESS TO SUBSCRIBERS. AFB'S ONLINE ELEARNING CENTER, OFFERING ACCESSIBLE, AFFORDABLE, AND AUTHORITATIVE TOOLS AND RESOURCES, WEBINARS, AND CONTINUING EDUCATION COURSES TO PROFESSIONALS IN THE VISION LOSS FIELD, WAS LAUNCHED IN FY13. SEVENTEEN NEW ELEARNING OFFERINGS WERE ACTIVATED, BRINGING THE TOTAL TO 47. ONLINE SALES INCREASED 543% IN FY13, AFB'S CENTER ON VISION LOSS (CVL) (HOUSED IN DALLAS) TOUCHED THE LIVES OF NEARLY 7,000 PEOPLE THROUGH DEMONSTRATIONAL TOURS, OUTREACH, AND SEMINARS. CENTER STAFF HOSTED SIX SEMINARS WITH OVER 350 CONSUMERS, FAMILY MEMBERS AND PROFESSIONALS ATTENDING. THE CENTER NOW HAS A WEBSITE (WWW.AFB.ORG/CVL) FEATURING ESTHER'S PLACE (THE CVL'S DEMONSTRATION MODEL HOME) AS WELL AS CVL NEWS.

	ADVOCACY & PUBLIC POLICY AFB'S PUBLIC POLICY CENTER CONTINUED ITS PURSUIT OF THE PASSAGE OF THE ANNE SULLIVAN MACY ACT (MACY ACT), COMPREHENSIVE DRAFT LEGISLATION INTENDED BOTH TO PROMOTE THE EXPANDED CORE CURRICULUM (ECC) (ENSURING THAT STUDENTS WITH VISION LOSS LEARN REQUIRED SKILLS) IN AMERICA'S SPECIAL EDUCATION LAW AND TO STRENGTHEN THE VISION LOSS FIELD'S CAPACITY TO PROVIDE THE ECC NATIONALLY. AFB PLAYED A LEADERSHIP ROLE IN EXTENSIVE NEGOTIATIONS WITH LEADERS IN THE LOW VISION COMMUNITY TO ENSURE THAT, TO THE MAXIMUM EXTENT POSSIBLE, THE MACY ACT ADEQUATELY ADDRESSES BOTH THE DEMAND FOR BRAILLE INSTRUCTION AND THE FULL AVAILABILITY OF LOW VISION DEVICES AND SERVICES. NEARLY FIFTY MAJOR NATIONAL, REGIONAL, AND LOCAL PROMINENT ORGANIZATIONS IN THE VISION LOSS COMMUNITY HAVE FORMALLY ENDORSED THE ACT, AND BOTH THE ECC/ADVOCACY ORG WEBSITE AND THE AFB ORG/MACYACT RESOURCES HAVE BEEN POPULATED WITH EXTENSIVE ADVOCACY TOOLS, WHITE PAPERS, AND HOW-TO GUIDES TO ASSIST CONSUMERS, PARENTS, AND PROFESSIONALS COMMUNICATE THEIR INTEREST IN THE PROMPT ENACTMENT OF THE MACY ACT. OVER 600 TELEPHONE CALLS WERE MADE BY THE GRASSROOTS TO CAPITOL HILL IN SUPPORT OF THE INTRODUCTION OF THE BILL DURING THE NATIONAL MACY ACT CALL-IN DAY. DURING THE WEEK OF THE CAMPAIGN, THE NUMBER OF USES OF AFB'S "TAKE ACTION" WEB SECTION IN SUPPORT OF THE EFFORT MORE THAN TRIPLED (FROM 812 USERS THE PRIOR WEEK TO 2,596 USERS). IN JULY 2012, PRESIDENT OBAMA SIGNED INTO LAW THE FDA SAFETY AND INNOVATION ACT WHICH CONTAINS THE AFB-DRAFTED AND -ADVOCATED PROVISIONS REQUIRING THE DEVELOPMENT OF BEST PRACTICES IN THE DELIVERY OF ACCESSIBLE PRESCRIPTION DRUG CONTAINER LABELING. THE U.S. ACCESS BOARD CONVENED THE WORKING GROUP (INCLUDING A REPRESENTATIVE FROM AFB) MANDATED BY THE LAW TO DEVELOP SUCH BEST PRACTICES, WHICH THE ACCESS BOARD PUBLISHED IN JULY 2013. THE BEST PRACTICES THAT HAVE BEEN DEVELOPED ARE BEING WIDELY REGARDED BY CONSUMER AND PROFESSIONAL ADVOCATES AS REASONABLE, USEFUL, AND CLEAR. AFB WILL EDUCATE THE VISION LOSS COMMUNITY REGARDING THE BEST PRACTICES AS PART OF THE TWENTY-FIRST CENTURY COMMUNICATIONS AND VIDEO ACCESSIBILITY ACT (CVAA), ENACTED IN 2010 AND CHAMPIONED BY AFB. SEVERAL POPULAR TELEVISION NETWORKS MADE CERTAIN PRIME-TIME AND CHILDREN'S PROGRAMS ACCESSIBLE TO VIEWERS WITH VISION LOSS BY ADDING VIDEO DESCRIPTION (SHORT VERBAL DESCRIPTIONS OF ACTION OR KEY VISUAL SCENES INSERTED INTO A PROGRAM'S DIALOG PAUSES TO PROVIDE CONTEXT) TO HELP CELEBRATE AND PROMOTE THIS INITIATIVE. IN FY13, AFB WORKED CLOSELY WITH ROVI CORPORATION AND COMCAST TO CREATE A DESCRIBED TV LISTINGS PAGE, AN ONLINE GUIDE WHERE VISITORS CAN DETERMINE WHICH SHOWS WILL BE DESCRIBED AS WELL AS WHEN THEY AIR.
